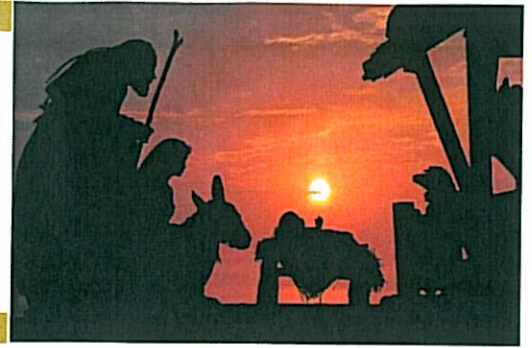

Dear Fellow Helpers,

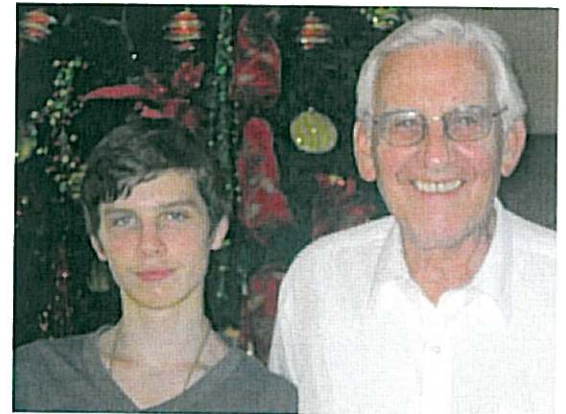

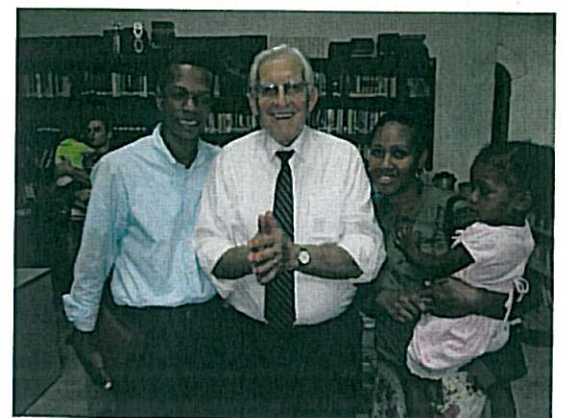
