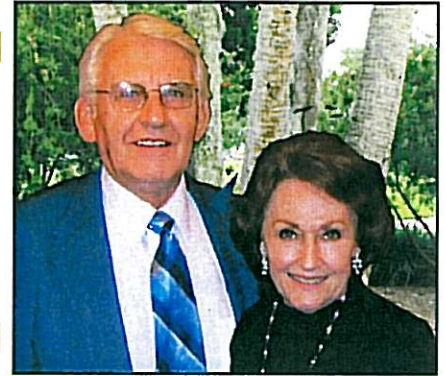




# Revival Crusade

At the end of May, we had preached/taught/counseled in 16 churches in 4 states, led a 10 Day Bible Study Tour of Israel, spoken to the State Convention of the Gideons of WV and participated in memorial services for two of God's children who are now with Him. In short, it has been a very busy spring. God has been good, but then, He always is!

Sadly, the economy of the country has had a disabling effect on our ministry. A few years ago, we had 41 Churches that supported the ministries of REVIVAL CRUSADE, INC. each month. That number has dropped to 35! Why? One church said "we want to send all our support to the field": Well, "the field is the world" and our monthly support to missionaries on each continent and our mission trips should surely be considered part of "the field". And, yes, the USA is part of the field. Other churches have stopped supporting our work because their income (tithes and offerings) have decreased severely. One, who formerly supported us, has stopped ALL missions giving, except for what their members do on short term mission trips. Some have assumed that we really do not need their support! I assure you that REVIVAL CRUSADE, INC. needs your support. Since my father began this ministry in 1961, (that is 50 years ago!) it has always been individuals and churches that enable us to continue and to expand our outreach. We are not underwritten by any large corporations or by any wealthy foundations.

There are open weeks in each month for the remainder of the year. The schedule is shown on the back of this page. Almost all of 2012 is open. So, some questions that come to mind are: is the Lord's coming so near that we do not need to consider the future of the ministry? Will our health fail us and prevent us from continuing to travel? Do churches not want an "older" man to minister to them? Yes, we know we are to trust God for the future (all of it), but you would probably be wondering the same questions if you were in our position. So, what are we asking of you?

Will you pray that God will continue to open doors of service for us? Will you ask God for our continued good health and for safety in travel? Will you make a special gift? Could your local church begin providing monthly support?

Again, we thank all who have supported us through the years. Your love, prayers and support is needed NOW. May our Lord richly reward you for being our fellow helpers.

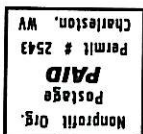
